Sue,

Please find below further information to inform the hearings regarding the Selsey Neighbourhood Plan. I would be grateful if you could forward this on to the Examiner:

"The following statement provides further clarification with regard to the flood zone classification for the Thawscroft site. It is hoped that this information will help address the question posed in the Examiner's initial comments, specifically "what is the nature of the flooding risk on the site and what is the timescale for the Environment Agency reconsidering the flooding status of the site having regard to the effectiveness of the Medmerry defences".

The site is currently identified within Flood Zone 3 (high risk) on the Environment Agency Flood Map for Planning.

This map is based on coastal modelling from 2011. We have a continuous process for updating our flood maps through new modelling. We are currently producing a new flood model for the coastline between Emsworth and Littlehampton which will consider undefended and defended scenarios for flood risk. It is anticipated that the outputs from this work will be available in the next couple of months. Whilst we expect some changes to the flood zones as a result of the modelling it is not expected that the Thawscroft site would be removed from Flood Zone 3.

Please note that the flood map for planning provides the level of flood risk from an undefended scenario. Whilst the Medmerry Managed Realignment is now working as an effective flood defence and protects and number of homes and infrastructure its presence will not significantly affect the reclassification of flood zones being carried out through the above modeling.

Whilst the site is identified within Flood Zone 3, in accordance with the NPPF, we support its removal as a site allocation.

I hope the above is of use. Unfortunately due to resources and other priorities the Environment Agency is unable to attend the hearing sessions on the 18th November. If you require any further information on this matter please let me know."
