## Notice of publication of the Proposed Modifications to the Submitted Site Allocation Development Plan Document 2014-2029

Chichester District Council has prepared Proposed Modifications to the submitted Site Allocation Development Plan Document 2014-2029 (DPD). Once adopted, this plan will supplement the adopted Chichester Local Plan: Key Policies 2014-2029.

The Site Allocation Development Plan Document 2014-2029 was submitted to the Secretary of State for independent examination in March 2017. As part of the examination, hearings were held in September 2017 where issues of legal compliance and 'soundness' were considered. Modifications to the submitted plan are now proposed to address these issues and this consultation provides those with an interest in the Site Allocation Development Plan Document 2014-2029 to make representations, stating whether the Proposed Modifications address these matters, by 5:00pm on Friday 16 March 2018. The representations will be considered by the Planning Inspector conducting the examination.

Representations should only relate to the Proposed Modifications. This consultation is not an opportunity to repeat or raise further representations about the published DPD or to seek further changes to the DPD.

The period for submission of representations will run for six weeks from Thursday 1 February 2018 until Friday 16 March 2018. Representations should arrive no later than 5.00pm on 16 March 2018. Anonymous comments or comments received outside these dates will not be accepted.
