Understanding your Council Tax Reduction

Please note your new year entitlement is calculated in advance and is therefore subject to change.

From April 2018 the council introduced a new CTR class for working age people in receipt of Universal Credit. If you are liable to pay Council Tax and are in receipt of Universal Credit your CTR award will be calculated with reference to the income bands below.

For claimant's receiving CTR under the banded scheme for UC claims there is a discretionary fund. This is for claims where it can be demonstrated that the scheme has financially disadvantaged them and caused financial hardship. Requests should be made in writing to the benefits team. What should I do if I think the decision is wrong?

The amount of Council Tax Reduction awarded is based on the household and financial information details you have given us. If you require a more detailed explanation this calculation, please contact the benefits office to request this. We aim to reply to you within 14 days.

If you are aggrieved by the way your Council Tax Reduction has been calculated you should write to the Council, stating the reasons why. The Council will consider the grievance and notify you in writing of the outcome. If you remain dissatisfied, or have had no reply within 2 months, you may appeal directly to the Valuation Tribunal for England.

What if my circumstances change?

You must inform us in writing of any changes in your circumstances, which may affect your claim straight away. **It is your responsibility to do this**. Do not rely on anyone else, such as the Department for Work and Pensions, to do this for you. Types of changes includes:

- A change in any type of income or savings; or
- A change to your household.

If you don't tell us about changes your claim may be incorrect and it may be determined that you are entitled to less Council Tax Reduction. This may mean that you will not have paid enough Council Tax.

It will be your responsibility to ensure that any additional amounts of Council Tax due are paid.

It is an offence not to tell us about changes in your circumstances that affect the amount of Council Tax Reduction that is awarded. Where you fail to advise of any changes in your circumstances we may decide to take further action, including criminal proceedings.
