## PLAISTOW AND IFOLD PARISH: NEIGHBOURHOOD PLAN - CONSULTATION STATEMENT TABLE

Since 2012, work has been undertaken by an evolving group of residents in a Steering Group under the auspices of Plaistow and Ifold Parish Council. The community engagement includes Public Consultations, surveys, public meetings and events. The policies contained in the Neighbourhood Plan are as a result of considerable interaction and consultation with the community.

In addition to specific consultation events, at each meeting of the full Parish Council a Neighbourhood Plan update has been presented with questions and comments invited from members of the public attending. The meeting minutes are publicly available on the Parish Council website or from the Clerk. In addition, steering group meetings are minuted and available on the dedicated Neighbourhood Plan website, linked from the Parish Council website. In this way any member of the public or parishioner has been able to access information. The Neighbourhood Plan website has been advertised at all events and allows information to be accessed by a range of people; parishioners, land owners, statutory bodies and consultees. Parish Council Noticeboards in each of the four settlements have also been used to publicize meetings, progress and consultations.
