Where are the plans for adequate shops/social centres? One Co-op, one Tesco, one Pub and one Club – not sufficient for these plans.				
Stop this excessive building – stop destroying the planet, our green spaces are vitally important for all of us. Build up areas breed despair and destruction. If you want more housing build some where you live and see how it impacts on you.
