The current proposal for the future development burden to fall on land to the east of Southbourne village is opposed on the following grounds:

- 1. The local highway network to the east of Southbourne village is unsuitable for increased traffic volumes. In particular, Cooks Lane and Prior Leaze Lane are narrow country lanes, with the inability, at frequent intervals, for vehicles to safely pass cyclists, horse riders and other vehicles. In addition, these lanes have no footways to enable safe pedestrian movement, particularly for those using them to access the nursery on Prior Leaze Lane and both the primary school and the Bourne Community College off of Stein Road. The traffic from the surrounding country lanes will naturally filter down Inlands Road in order to meet the A259, which is the main road between Chichester and Emsworth. This is another road that is totally unsuited for use as a major road artery. Inlands Road has a dangerous and visually obstructed level crossing and the junction with the A259 is both narrow and has an inadequate visibility splay, leading to inevitable traffic congestion, and unacceptable levels of noise and air pollution.
- 2. The original concept of the "Green Ring" to protect village identities is being significantly undermined. This proposal to build to the east would allow for almost continuous ribbon development from Southbourne to Chidham/Hambrook, which will destroy the unique character and appearance of the Chichester Harbour area, which is both an Area of Outstanding Natural Beauty and a Site of Special Scientific Interest.
- 3. In addition to undermining the local amenity, the proposal to build to the east will also compromise environmentally important, natural, flood management features, destroy ecologically significant habitats and disrupt the wildlife corridor linking the South Downs National Park to the north and Chichester Harbour AONB/SSSI to the south.

Whilst the build of further dwellings is, regrettably, inevitable, the impact this will have on the local infrastructure cannot be ignored. In particular, the waste-water treatment capacity at South Water's Thornham Plant is currently at capacity, with unacceptable and frequent discharge of untreated effluent in to Chichester Harbour. Whilst Policy SB2 paragraph (r) refers to a future, phased capacity improvement, this work needs to start now in anticipation of the build of additional dwellings.

Before a final decision is taken to permit development on land to the east of Southbourne village, there should be:  1. A full road safety audit; and 2. A full wildlife and ecological survey of the area
