However, my concerns are fundamental to the whole idea of additional housing in the parish and the district. At present we have the entirely unsatisfactory situation where Southern Water (SW) cannot cope with processing waste water adequately, and regularly discharge untreated sewage into Chichester Harbour. This has got to stop. Until the Government can force SW to process the waste water from existing homes, then it is entirely futile to even think about adding more homes to the area. To do so will make the situation even worse. I understand well about planning policy, and the fact that we are being 'forced' to accept more new homes. But this really is a nonsense if the infrastructure cannot cope. I hope that the Inspectors will make a sensible decision and put any additional homes 'on hold' until the infrastructure is sorted out satisfactorily and SW are legally required to STOP discharging waste water into the harbour. | | | | | | | |
