I would like to record my opposition to the proposed minimum of 1250 new homes build in the strategic gap between Southbourne and Nutbourne. There are a huge number of practical reasons for my objection, but it also concerns me that such destructive action has a moral impact in terms of who is to take responsibility for irreversibly destroying habitats for both wildlife and future residents of both Southbourne and Nutbourne.

Water Management – [Habitat P.30 and 35 Environment management 47, 48 and 49 – Policy EM1] Water finds its way to the sea and with all new building areas localised flooding has increased in gardens, on roads and in any place, water can fill when its natural flow lines are filled in or removed. This of course would be of no consequence to developers because they create the problem with their builds but are long gone when the residents and other taxpayers must pick up the bills to sort flood damage. If developers or council members lived locally to proposed build areas in Southbourne and Nutbourne they would see the impact of trapped water courses.

Wastewater is regularly pumped into Chichester harbour because the Thornham Wastewater plant does not have the capacity to cope with current levels of demand. The harbour is polluted, and more wastewater will only increase the health hazard it is already creating. We are seeing far more visitors to the area on holiday, who is responsible for letting them know what a biohazard the harbour is if they venture too close. What financial contribution do the developers make to Southern Water to give them the chance of managing increased demand?

Main Road – [Local Planning Framework 5 Constraints] This road is now as busy as it was before the A27 trunk road was built. Houses shake, and pollution is so bad now car exhaust fumes can be smelt indoors if you open a window to the main road. Some insane, completely deluded soul feels we have continuous cycle lanes between Chichester and Emsworth and to make this even better [which is amazing because it does not exist!]; the proposal is to have cyclists and pedestrians sharing a pathway!!! Cyclists use the road because the cycle lanes are so poorly surfaced and are dangerous and are not continuous. Pedestrians have inadequate, narrow, uneven paths to negotiate and already must dodge cyclists on these paths that provide some protection for cyclists from speeding cars and lorries. Come and check it out for yourselves, pedestrians and cyclists cannot safely share the same path.

The junction between Broad Road and Main Road is dangerous, no doubt the developers with

their community minded, safety heads on will be building a roundabout here?
Irreversible damage to the natural green corridors- [EM3 and H3] When the damage is done everything is lost for the wildlife, both villages for ever. This level of cavalier indifference is beyond comprehension and understanding.
Shops, Schools, Doctors, Dentists – [Requirement for homes 42,43,44,45] By consensus of developers and council members = not important so therefore not needed!!
