31st August 2018 15.30pm Andrew Carrington, MD Strategic Land, Countryside met with Terry Tedder Regional MD, Bloor Homes Eastern at 3pm at Brentwood offices on a different matter. Whilst in the meeting Andrew told him Countryside were Chichester Council's development partner on the Tangmere site and that as we were advised that Bloor had an option over Heaver land we needed to discuss this with them and the prospect of a agreeing to enter a private treaty with them rather than a CPO. Terry said the site was held with a different region but he would get the right person to contact with us.

10 September 2018 15.46pm	Nicholle Phillips called Colin Wilkins and introduced Countryside as the newly announced Development Partner for Chichester District Council as part of their CPO process for the Tangmere allocation site. She explained that the CPO process required Countryside to seek discussions with the various landowners comprising the Tangmere Allocation site and try to enter into private treaty with them, rather than CPO, as best practice. Colin Wilkins thanked her for the call and confirmed he represented the Heaver land on the site. He said we were welcome to put forward an offer for Heaver's land when we were ready and following this his client would consider it. Nicholle Phillips said to give her a couple of weeks to see everyone and then she would be in a position to start putting together the offers.
11 September 2018 13.25pm	Simon Breen, Senior Land Director, Bloor Homes Southern emailed Andrew Carrington to introduce himself and said if we wanted to meet to discuss this further he would be pleased to host. He said he would involve his planning colleague as well, given her ongoing involvement. He said his diary was full for September but he could meet in October if Andrew sent a few dates over.
12 September 2018 11.15pm	Andrew Carrington thanked him and said Nicholle Phillips would be in touch shortly with some suitable dates for a meeting to discuss.
12 September 2018 16.57pm	Nicholle Phillips first called the Nigel Jones office, then finding he was not there, secured the email for the agent for this CS East / CS South - Nigel Jones at Chesters Commercial to introduce herself saying Countryside had been appointed by Chichester Council to act as their development partner regarding this site last week. She said she was now contacting all parties to arrange to meet up, and that she would be happy to go to Yeovil next week (diary allowing) to meet him on Monday, Wednesday or Thursday. She also said it might be helpful if he called her – or email – to let her know what date and time might be suitable.
13 September 2018 17.57pm	Nigel Jones replied by email saying he was away the following week so to please suggest some dates for the week after.
13 September 2018 18.34pm	Nicholle replied saying she could make 24th, 27th or 28th September.
14 September 2018 16.35pm	Nicholle Phillips emailed Simon Breen to ask if he had a mobile number she could call him on to organise a meeting as soon as possible give the tight timetable Countryside were working to. She said she needed to see him as soon as possible – ideally in the next few days.
14 September 2018 16.35pm	Simon Breen then called Nicholle Phillips and agreed a meeting time for 10.30am on the 20th September at Bloors offices in Newbury. Nicholle Phillips discussed for 35 minutes the programme, Countryside's role, and tried to find out as much as possible about Bloor's position. Regarding their option, Bloor said they had an option over Heaver land but were not able to collaborate with 3rd parties and had to keep its contents confidential.

19 September 2018 16.25pm	Simon Breen then cancelled the meeting having discussed things briefly with Bloor lawyers. He said he would need landowner approval prior to having any meeting - otherwise he would be in breach of his agreement. He said his colleague would be speaking with the Heaver family over the next few days so he would need to rearrange the meeting in due course.
24 September 2018 16.52pm	Nicholle emailed Nigel Jones again following Nigel's return from leave now offering 3rd or the 9th Sept. (or other dates available in other locations than Nigel's offices in Yeovil) or alternatively a phone call.
25 September 2018 16.03pm	Nigel Jones replied by email having returned from leave to say the 3rd would be OK. Nicholle replied yes to this immediately and a time was set for 12noon at Nigel's offices in Yeovil.
27 September 2018 8.25am	Colin Wilkins called Nicholle Phillips to ask when she thought an offer would be forthcoming for Heaver land, and also whether she had managed to see all the parties. Nicholle Phillips confirmed that she had now spoken to all the parties except for Nigel Jones (with whom a meeting was booked for the 3rd October due to his being on leave). Nicholle Phillips said that she had a meeting with Bloor Homes cancelled as they had taken advice from their lawyers that they could be in breach of their agreement without seeking approval of the landowner. Colin Wilkins said he was surprised by this, and Nicholle Phillips asked him to urge Heaver to give approval to for them to see Countryside as soon as possible. Nicholle Phillips confirmed regarding progress on private treaties that she was attending a legal conference later that morning to agree the way forward regarding the offers to the various parties and that she was hoping to be in a position to issue an offer in about two weeks. He said he was going to update the landowner following the conversation, including the fact that Bloor needed his approval to meet with Countryside.

Nicholle Phillips emailed Colin Wilkins to say she was just waiting for Council approval prior to going out to landowners with a proposal and that hopefully this would be in the next few days – and she would contact him as soon as she had this.
Colin Wilkins emailed Nicholle Phillips to say thanks for the update.
Nicholle Phillips emailed Colin Wilkins the Countryside offer for Heaver land.
Colin Wilkins emailed to thank Nicholle Phillips for the offer and confirmed he had forwarded this to his clients, and would respond further when he had their instructions.
Nicholle Phillips emailed Nigel Jones the Countryside offer for CS East and CS South land.
Colin Wilkins called Nicholle Phillips.
Colin Wilkins emails Nicholle Phillips.
Following an internal meeting, Nicholle Phillips emailed Colin Wilkins to say she was having a meeting to discuss on Wednesday 14th November and would get back to him shortly after that.

Daniel Hagger confirmed the ground would be made good where possible else compensation would be offered, and said would need to seek advice regarding compensation for monitoring damage.
