

Working together to tackle climate change



The threat of climate change is a huge concern to us all. There have always been natural variations in the climate, but scientists say temperatures are now rising at an alarming rate – and it's caused by people. The world is currently around 1.2C warmer than before people started using oil, gas and coal to power factories, transport and to heat homes.



As a council we are committed to working with you to tackle climate change. Last year, we developed a Climate Emergency Action Plan and we have been working hard to put in place actions and schemes that will help us reduce the impact we have on the environment. Below you can find out more about what we have been doing and how you can play your part.

What are we doing?

Moving to electric vehicles

As a council, our refuse collection fleet is one of our biggest sources of emissions, which is why we will be introducing two electric vehicles next year. The typical diesel refuse vehicle achieves just three to four miles to the gallon and while an electric refuse truck costs almost twice that of a diesel version, we expect that the total costs over the lifetime of the vehicles to be similar to diesel due to their lower running costs.

Powerful batteries are needed to operate these very specialist vehicles as they are heavy and constantly stop and start. In addition, the trucks need huge amounts of power to squash all the waste down.



We're also planning to introduce changes to our waste and recycling collection routes to help reduce mileage.

We've already started switching our other vehicles to electric, we have a couple in our parking services team and we plan to replace more of the team's vehicles in future. Our car parks also have 18 electric vehicle charge points across the district to help residents and visitors who have electric cars.

Tree planting

We've recently launched a new community tree planting scheme to increase tree cover in rural and urban areas across the district. The initiative is part of a £2.5m project with the Department for Environment, Food and Rural Affairs and we are one of several councils taking part across the country.

This summer we opened the scheme for giving out free trees and during the current planting season we will be distributing around 8,300 trees to more than 100 successful applicants. These included residents, community groups, landowners, schools, charities, parish councils and businesses. As part of the wider scheme we will also be planting two mini urban forests in public spaces in our district, and funding tree planting on farms and private land. Although the scheme has closed for this year, a similar

scheme will also be running during 2022.

Protecting our wildlife corridors

Chichester and Pagham Harbours are connected to the South Downs National Park through a series of wildlife corridors, where woods, hedgerows and streams allow different species to move across the district for food and to breed.

Protecting these corridors is important to ensure the sustainability of future wildlife populations in the district. This project will deliver a range of actions to enhance the Strategic Wildlife Corridors and safeguard the district's wildlife. It also aims to help the district's wildlife become more resilient to environmental change; engage local people with their district's wildlife; and build on the knowledge and expertise of our current Community Wildlife Officer. Increasing our energy efficiency

In our Climate Emergency Action Plan, we set out a carbon reduction target of 10% year-on-year for the district council until 2025.

The plan outlines the steps that we are taking to cut emissions within the work that we do and to improve the energy efficiency of our council buildings and to reduce emissions from our vehicles.



We have installed low-energy LED lighting and we also have solar panels on our main offices as well as solar thermal power. This reduces the amount of energy that we take from the power grid, while our gas boilers don't have to be on as much heating water. We are working further to decarbonise the buildings that we own, starting with Westgate Leisure Centre, which is another one of our biggest emission sources.

Our own emissions are just a small part of the district's emissions as a whole, and so we will also be bringing people and organisations together to help them reduce emissions in their homes, their workplaces, and in other aspects of their lives. We'll also be working to help businesses and organisations to develop projects that will help reduce greenhouse gas emissions.

Waste and recycling

This year, we launched a new commercial food waste collection service to help businesses across the district reduce their impact on the environment.

We also launched a pilot kerbside collection of textiles and small electrical items and we have linked up with the Podback scheme to enable residents who use coffee pod machines to recycle their coffee pod containers. We are also running a pilot



scheme of 'hot bins' – special compost bins that turn garden and food waste into compost much quicker than the average compost bin.

Encouraging more cycling and walking

We have produced a 10-year Local Cycling and Walking Infrastructure Plan (LCWIP) which identifies long-term cycling and walking improvements that are needed to help encourage an increase in the number of people using these as modes of transport.

We are working closely with West Sussex County Council and other partners to work towards delivering these infrastructure improvements, which will include bidding for Government funding and contributions from developers and third parties.

As the transport authority, the county council will assess different projects in the LCWIPs across the county, to produce an order of priority for delivery.

What can you do?



- Reduce your reliance on cars by taking public transport or cycling.



- Insulate your home

Generating renewable energy in your own home and making it as energy efficient as possible are two of the biggest things that you can do to reduce your greenhouse gas emissions. Even small DIY measures, such as fitting a hot water cylinder with an insulation jacket can save you £20 a year in heating and 150kg of carbon dioxide. There are many grants available to help householders and landlords make homes greener. - Reduce your food waste and freeze any leftovers.

- Recycle as much as you can.

As a district, we are already recycling 45% of waste, but it's important we increase this further. You can find out more at www.chichester.gov.uk/wasteandrecycling

- Save water

On average, people in this area use more water than many other areas. Around a third of gas and electricity used in a typical home goes on heating water for washing, cooking and cleaning. We can all take simple steps such as having a shorter shower and not leaving the tap on when we brush our teeth. Government housing targets unlikely to be met due to infrastructure and funding issues.



Our Deputy Leader and Cabinet Member for Planning, Councillor Susan Taylor, provides a detailed update on the Chichester Local Plan.

I want to personally update you on our progress with the Local Plan Review.

Before I go into the detail, it's important to explain that before any council submits their Local Plan to the Planning Inspector, they have to show that they have tried and tested every possible way to reach the housing numbers set by Government. No stone can be left unturned. This means that all of the work that we have carried out to date has been absolutely vital in demonstrating the complex situation we are in.

As you know, we have carried out extensive work and research that shows that improvements to the A27 Chichester Bypass, a Stockbridge Link Road and sustainable transport infrastructure are required in order to meet our housing needs as determined by the Government.

The most recent estimated cost for delivering improvements to the A27 Bypass, which would be required to deliver the level of housing we are expected to take, would be around £65 million. As things stand, we may be able to secure £33-£45 million of this from developer contributions, and so the remainder would have to come from other funding sources.

Following discussions with those who fund strategic infrastructure, including West Sussex County Council, National Highways and Homes England, the council has concluded that the additional cost of the A27 mitigation package, after developer contributions are taken into account, cannot currently be met. Other funding options have been examined, including exploring other potential public sources of funding and discussions have also been held with Coast 2 Capital Local Enterprise Partnership, but the funds required are not available. As a result, there isn't the funding to deliver the full package of A27 mitigation improvements. It's also worth explaining that the A27 mitigation package considered in the Local Plan is not the long-awaited national road scheme on the A27; and would only deal with additional traffic from the new development.

This means that the Chichester Local Plan is currently unlikely to be able to meet the full housing targets set by the Government due to a lack of external funding for infrastructure improvements. We are now working closely with National Highways and West Sussex County Council to establish a revised Development Strategy based on improvements that can be delivered to the A27 during the plan period.

We've always said that the roads and waste water are the biggest challenges facing the plan. However, we have to show that we have investigated all options and solutions before the Government will consider a lower housing target.

I appreciate that it may be hard to understand that while we are delivering the Local Plan, many elements of it — mainly roads and waste water — are totally out of our control. This is what makes this process so challenging. The Local Plan is a bit like a jigsaw, you have to make sure that all of the pieces fit.

It's also easy for people to say, we told you that the housing numbers couldn't and shouldn't be delivered, but this isn't how the planning system works. The Planning Inspector will want to see that we have investigated every single option and that we have the evidence to back this up. Just to give you an idea, our officers have already produced 41 different policy documents. They have been working flat out to try and move this forward and it has continued to be a top priority for us, even though we have also been responding to the pandemic. We need to go through this process and gather the evidence in order to get the best outcome for our residents and businesses and keep planning decisions locally.

We've spoken to a Planning Inspector who has said that before concluding that our housing needs cannot be met, we need to determine what level of housing could be achieved based on deliverable improvements to the A27; consider whether our full housing needs could be met another way, which would include looking back at other parts of the local plan area; and investigate if neighbouring authorities can help meet our housing needs. While the inspector did not rule out us proceeding with a lower level of development in the emerging local plan, he did emphasise there is a 'high bar' to justify such an approach.

Moving forward, we will follow the steps that the Planning Inspector has outlined so that we are in a strong position to make our case when the plan is submitted for formal examination. Within this, we currently expect to have to outline our intention to review the plan again if a national road scheme for the A27 at Chichester is brought forward, enabling a higher level of housing delivery. We intend to keep you fully

informed throughout this process, and will let you know as soon as we are ready to consult with you.

Over the past couple of years, we have sent letters and been involved in meetings with Government officials to explain the complex issues affecting the Chichester plan area. Recently, the Council Leader and Chief Executive, along with Gillian Keegan MP and Andrew Griffith MP, met with the Minister for Housing to discuss these issues and to request that the area is treated as an exceptional case. Unfortunately, the request was not agreed. It was also made clear by the Minister that if the council can demonstrate through planning evidence assembled through the Local Plan process that the area cannot meet its full housing needs then the Local Plan may be submitted for examination on that basis. Over this period we have also involved the Government's Planning Advisory Service and we have highlighted our concerns to the Planning Inspectorate.

We understand that local people are concerned and we want to reassure everyone that we have robust measures in place to protect the plan area from inappropriate speculative development until the Local Plan Review is adopted. Every planning application is considered carefully by the council. As part of this process, we consult with relevant organisations such as Southern Water, West Sussex County Council, the Environment Agency, Natural England and National Highways. If any of these organisations highlight significant problems which cannot be overcome, then an application would be refused.

In addition to this, we have introduced an Interim Housing Policy Statement. This is part of our rule book for planning applications and this considers other factors, such as the protection of strategic wildlife corridors and Environment Agency advice on flooding.

In response to people calling for a moratorium, even if we wished to delay investment in homes and jobs, under law, developers have the right to submit planning applications which must be determined within agreed timescales. If not, they have a right of appeal to the Planning Inspectorate and we may even be found to have acted unreasonably, with applicants appeal costs awarded against us.

The council must also be able to substantiate any grounds for refusal of permission, with consultee support where relevant at any subsequent appeal. At this stage, relevant consultees have not requested a moratorium in respect of either transport or wastewater issues and so this is not an approach that would be held to be reasonable or defensible. We want to reassure people that we have measures in place to protect the plan area until the Local Review can be adopted.

Discussions are also ongoing with Southern Water, which is responsible for wastewater, and the Environment Agency, which is responsible for enforcing the discharges into the harbour from premises that require permits, such as the wastewater treatment plants. While an engineering solution can be found to accommodate future growth, environmental limitations are a constraint, particularly in the western part of the plan area. We have been working with both organisations to agree a position through a Statement of Common Ground. At the time of writing, this statement has been agreed and we hope to publish this shortly. Infrastructure options are being examined by Southern Water over the next year, but these will not be confirmed until 2023. All of these discussions and work will form part of the evidence to highlight the challenges faced by the plan area.

Please be assured that we are doing everything we can to progress this important piece of work and get the very best outcome for our district.


Support your local farmers' markets



Transforming lives

Over the past year, our Rough Sleeper Outreach Team has been working hard to help people turn their lives around and access specialist support and new opportunities. Working with local homeless charities – The Four Streets Project, HEART and Stonepillow – the team is working on a number of projects which are having a positive difference on both the individuals concerned and the wider community. The team, led by Tom Polhill, is doing a fantastic job engaging and

working with individuals, and in October was even nominated for a Sussex Police award for their work supporting vulnerable people during the pandemic.

I am also pleased that our Make Your Change Count campaign – which encourages people to support these charities, rather than give directly to people on the street – has also been having a positive impact. Local charities are reporting an increase in donations, as well as more volunteers keen

to help them in their work. By diverting your donations to these important organisations, you are enabling them to support new rough sleepers off the street; prevent ex-rough sleepers returning to the street; and, prevent vulnerably housed people becoming homeless, encouraging them to access the right help to transform their lives. On these pages, we outline some of the key projects that our Rough Sleeper Outreach Team have been working on with our incredible local partners.

City centre lockers

In September, a project to install a series of lockers for rough sleepers and other vulnerably housed people was launched. The lockers are situated in a discrete Chichester city centre location so that rough sleepers are able to store some of their possessions and do not have to cart them round. The idea is to support people so that if they have situations like job interviews, they are able to do this without the worry of bringing all their belongings with them, or leaving them in exposed locations. The lockers have been funded thanks to a grant from the local Joint Action Group (JAG) with help from our council. They will be overseen and maintained by Stonepillow.

Raising awareness of the rough sleeping partnership

Over the last few months, we have had a stall at the Chichester Farmers' Market so that we can talk to people about the rough sleeping prevention partnership and the work that our council and local charities are delivering. In addition to this, we are able to offer information on what support is available and advise people on how they can report rough sleeping through www.streetlink.org.uk

Teaming up with Everyone Active

A project has just begun with the council's leisure provider, Everyone Active, to help a number of former rough sleepers who have secured long-term accommodation. Everyone Active has devised a 12-week programme which focusses on personal training and personal wellbeing. The scheme aims to increase not only physical health, but clients' self-confidence. The course has been funded by money which Everyone Active applied for with our support, and if the scheme is successful, then there is scope to extend it further.

Applying for government funding

We have also successfully bid for a number of Government grants to support a variety of projects. This includes a programme led by Stonepillow which will prevent ex-offenders becoming homeless and provide the support they need to secure settled accommodation when they leave prison.

Through the money secured, Stonepillow have been able to recruit four staff who have been working with us to help prevent clients returning to street homelessness. These roles work directly with clients and local support agencies to create effective support package for each individual.

The opening of Hicks House in July was warmly welcomed after months of hard work in partnership with Stonepillow. The accommodation, a development on the existing lodge, will add an additional six units of accommodation. There are now 12 units in total. Hicks House will offer self-contained studio flats for rough sleepers with complex needs on the first stage of their journey to independent living.

Increasing short-stay accommodation

Earlier this year, we started building our new short stay accommodation, and we're pleased to say that work is progressing really well. This important project will mean that we can provide an additional 17 flats, increasing the amount of much-needed short stay accommodation for people who are facing homelessness in the district.

The first stage of the project is now complete, with three refurbished flats now ready for use in the existing building. The new flats are also coming along really well – at the time of writing this, the roof tiles were being laid and solar panels installed. Working with our local partners to make a difference

Tom Polhill is our Rough Sleeper Team coordinator and says that a huge amount of work has been undertaken to help people change their lives:

Our rough sleeper outreach team with our partners at Stonepillow.



“Rough sleeper numbers are very low in the city at the moment. This is down to a combination of us housing people and moving people on from temporary accommodation to long-term accommodation.

“Between our council, Stonepillow, FourStreets and HEART, we have a really strong partnership and we know that it is really making a difference. In addition, the Make Your Change Count campaign has been really successful in raising awareness of the different charities and how people can help, as well as educating people about the work that is being done to reduce rough sleeping and homelessness. The members of the public that we have spoken to have

been pleasantly surprised by the extent of the work being done and that all the organisations are working together and not in isolation.

“The circumstances and experiences of each client can be extremely different; we offer a very person-centred approach. We've had some positive results of people who we have helped. Currently, the success is mainly around people securing and retaining accommodation for the first time in their lives – some of these have been long-term rough sleepers for whom, going into and keeping accommodation can be a very difficult thing for them. We are now looking at extending the support we offer to these clients, including through

the partnerships with the university and Everyone Active. It's about providing people with opportunities in order to help them move out of the situation that they are in.”

“Although we have been able to help many people, there will always be those who choose to stay on the street. In these cases, our team will continue to reach out to them, keep in contact, earn their trust and encourage them to take up support when they are ready.”

“Thanks to the combined effort of our team and our partners we have massively reduced rough sleeping over the last 18 months and it's as a result of everyone working together.”

Continue to Make Your Change Count

People across Chichester District are being urged to carry on making their change count as part of a partnership project to help bring lasting change to the lives of rough sleepers.

We are working closely with homeless charities The Four Streets Project, HEART and Stonepillow to encourage people to give to these charities so they can support rough sleepers long-term, rather than giving money directly to people on the street.



Community Wardens partner with local charity to support the most vulnerable

A local project run by the Selsey Community Forum, which is supported by Chichester District Council's Community Wardens, has been providing a vital lifeline to vulnerable people in Selsey and Bracklesham and the Witterings.

The Good Morning Selsey/Bracklesham and the Witterings schemes aim to combat loneliness by making telephone calls to check in on local people who may be vulnerable or who live alone.

Hundreds of calls are made each day by 25 volunteers, who offer friendly support to people across Selsey and Bracklesham and the Witterings, while two part time staff members from the Selsey Community Forum coordinate the scheme.

If the volunteers are unable to reach someone, they contact the council's Community Wardens, who carry out welfare checks to make sure that everything is okay.

Mike Nicholls, who chairs the Selsey Community Forum, says: "We have nearly 100 residents using our service to help them connect with other people. A lot of these people only have the radio or TV to know what's going on outside their homes, so even a half hour conversation with another person can really brighten them up and help keep them connected."

"We have really come into our own during the pandemic. Before, many people were visited by their family and friends, but the risk of Covid-19 has kept everyone inside. Without these phone calls older people in Selsey and Bracklesham and the Witterings may not have had a conversation for weeks or longer."

"And, with the help of our local Community Wardens, Neil Hill and Drew Allardice, we've been able to help keep those using our service safe and looked after."

Neil Hill, Community Warden for Selsey, says the partnership has made a huge difference: "If we don't get a reply from someone for a couple days then the team will let me know. I then go round to the person's house and just check everything is okay. Sometimes they've gone on holiday or been taken to hospital, but in more serious cases they need urgent help. If this is required, I call the emergency services and make sure they get the help they need."

"The scheme really is a lifeline for many people here and thanks to Mike and the rest of the team we've been able to help a lot of people. We've also been able to put people in touch with council services that can offer further support."

The scheme receives a grant from Chichester District Council, along with money from charitable trusts and donations, so that it can continue to be delivered free of charge.

Mike adds: "If one of our residents goes into hospital, we keep up the phone calls with them, and if they go to a care home we ring them as long as they want us to, until they feel settled. We take this approach because we know how valuable this connection can be."

"We couldn't do any of this without our brilliant volunteers and we're always looking for more. If people want to get

involved and help their community, they can call the Selsey Care Shop on **01243 201616** or contact the Community Wardens. After a DBS check we can give volunteers all the training and support they need."

Councillor Roy Briscoe, Cabinet Member at Chichester District Council for Community Services and Culture, says: "We are so lucky to have such caring people in our district who give up their own time to help those who are vulnerable or lonely. As a council we are proud to support Good Morning Selsey/the Witterings schemes through both our Community Warden Service and grant funding and seeing the difference it makes."

Reducing wood burner pollution

- Buy a stove approved by the Department for Environment, Farming and Rural Affairs. You can search for appliances and fuels at the <https://smokecontrol.defra.gov.uk/search.php>
- Have it installed by someone competent and who can also show you how to operate it efficiently. Find out more at www.burnright.co.uk
- Ensure that you use smokeless fuels or dry, well-seasoned wood. Look for the Woodsure Ready to Burn logo where wood is guaranteed to have a moisture content of 20% or less.
- Consider frequency / duration of use.
- Get appliances serviced and flues cleaned regularly.
