The Examination into the Southbourne Parish Neighbourhood Plan Review 2019-2037 is underway and the Examiner has requested a period of consultation on the following amendments only to the submitted plan.

The amendments relate to the incorporation of Policies 2, 3 and 8 and their supporting text from the earlier 'made' neighbourhood plan, previously contained in Appendix A of the submitted plan, into the main body of the submitted plan.

The focussed consultation is on the following amendments to the submission version of the plan as set out below:

1. Delete Appendix A in its entirety and renumber Appendix B to G as Appendix A to F
2. Update Policies 2, 3 and 8 and supporting text of the Southbourne Neighbourhood Plan 2014 – 2029 and renumber as Policies SB23, 24 and 25
3. Insert the updated policies SB23, 24 and 25 and supporting text into page 73 of the submission version of Southbourne Parish Neighbourhood Plan Review 2019 – 2037 and update policies maps accordingly.
